- 2. The FUND TRANSFER FORM is used when a transfer of existing units is being requested. The transfer can be specified in terms of:
 - a. An amount of unit value, using the AMOUNT columns. The value in the Amount column cannot exceed the values currently reflected in the funds individually or totally.
 - b. A percentage amount of unit value, using the % OF FUNDS columns. The total percentage on the TRANSFER UNITS TO: section must equal 100%.
- 3. There is a charge for the service of transferring existing units from one fund to another. The charge depends on how frequently such transfers are requested and is a percentage amount applied to the amount of money transferred. The charges are subject to change without notice.
