Beneficiary Privacy Notice

1. About this Privacy Notice

The Trustees of your Pension Fund and Employee Benefits Administrator Limited (a subsidiary of Sagicor Group Jamaica) ("We"), are committed to the protection and security of your personal information.

It is important that you read this privacy notice so that you are aware of how and why we collect and use such information. This notice applies to anyone who interacts with us in relation to our pension funds administration which includes enrolment, administration of the relevant schemes and offboarding.

2. The personal data that we collect and process

We collect personal information about you which is submitted to us by members during the member's onboarding or offboarding.

We may collect additional personal information from you through your contact with us, including by email, by post or by filling in other forms.

3. The categories of personal data that we process

We currently collect and process the following standard personal information:

Beneficiary information

- Personal information; beneficiary name, date of birth, address and contact number, relationship to member, email address
- Tax information; TRN
- If a minor is a beneficiary, their Trustee information will be collected.

We may need to collect additional information from you directly.

The above information is collected specifically for the purposes of: enrolment into a pension scheme; administration of the scheme; preparation of communications and relevant offboarding activities.

4. The purpose and legal basis for processing your personal data

We process your personal information for the purposes set out in this privacy notice. Under the Jamaica Data Protection Act 2020, the purpose and lawful basis that we rely on to process your data are outlined below.

Purposes of processing

- To facilitate an efficient and effective pension process and customer service

 Performance of a contract
- To ensure current and future members' pension provision is matched to their requirements
 - Legitimate interest (for marketing and product development), legal obligation and performance of a contract.
- To manage pension fund
 - Performance of a contract
- To receive payments

- To identify and communicate with you

- To detect, prevent and investigate fraud

 Legal obligation and our legitimate interest
- To assess and improve business performance
 - Legitimate interest
- To meet our "know-your-customer" (KYC) and anti-money-laundering (AML) obligations
 - Legal obligation
- To report to regulators
 - o Legal obligation

5. Sharing of your personal data

We sometimes need to share your information with other people or organisations for the purposes set out in this privacy notice. The exact information we share depends on the reason we are sharing it.

As part of our pension scheme administration process, we may share your information with:

- Regulators who are responsible for ensuring that our pension schemes conform to the relevant regulations; and
- External Auditors.

If we share your personal information, we will make sure appropriate safeguards are in place to protect your personal information in accordance with data protection laws.

6. Retention of your personal data

We keep your personal information for a period of 7 years after it is no longer needed which is based on the following criteria:

- When you cease to be a beneficiary of one of our pension schemes;
- Any periods for keeping information which are recommended by regulators, professional bodies or associations; or
- Any relevant proceedings that apply.

Personal data is stored securely and in accordance with periods specified in our data retention policy. At the end of the relevant period your data will be securely disposed of in accordance with our data disposal procedures.

7. Your rights

You have the following rights under the Jamaica Data Protection Act 2020 and may also have these rights in other jurisdictions where applicable data protection laws are in place (please note that certain exceptions may apply):

- **Right of access**: you have the right to make a request for details of your personal information and a copy of that personal information.
- **Right to rectification**: you have the right to have inaccurate information about you corrected or removed.
- **Right to object**: you have the right to object to the processing of your data for specific purposes, unless these purposes have been expressly stipulated by a Regulatory Body
- **Right to be informed**: you have the right to be kept up to date with the progress of your pension enrolment, as well as any changes that may be made to your pension scheme in the future
- **Right to limitation of processing**: you have the right to ask us to cease the processing of your personal data if you feel that the processing will cause undue damage or distress. Additionally, you have the right to ask us to stop

sending you any communications relating to the administration of your pension scheme

Please note: These rights are not absolute. This means they do not always apply in all cases, and we will let you know in our correspondence with you how we will be able to meet your request relating to your rights. Facilitation of rights requests is done on a case-by-case basis.

If you make a request, we will ask you to confirm your identity if we need to, and to provide information that helps us to understand your request better. Once we have received your request, we will tell you what action we have taken within a maximum time frame of 30 days of receiving your request and will inform you of any statutory extension of the period for attending to your request. We may require a fee to provide you with the requested data and will provide further details about any payments that need to be made subject to receiving your request.
