NOTICE is hereby given in accordance with the Companies Act Cap 308 of the Laws of Barbados that the Directors of Sagicor Financial Corporation (“the Company”) have by resolution declared an interim dividend of **3.25 cents per share United States currency (US\$)** on the outstanding **Convertible Redeemable Preference Shares** (Preference Shares) in the capital of the Company, to be paid on **November 15, 2013** to the Convertible Redeemable Preference Shareholders of record at the close of business on **October 15, 2013**.

Preference Shares will trade “ex div” from **October 11, 2013**. Only those Convertible Redeemable Preference Shareholders of record on **October 15, 2013** will be entitled to receive the interim dividend.
