## Say Hello to Telemedicine

## faqs

### ⊖ What is telemedicine?

A consultation with a Provider where you communicate using video conference or telephone, instead of having a physical face-to-face visit with a provider.

### ⊖ Can I access telemedicine services from my current doctor?

You will have to contact your doctor to verify the following:

1. He is offering telemedicine service.
2. He/she has been onboarded with Sagicor to offer telemedicine service, for claims to be reimbursed.

### ⊖ Is there an additional cost for telemedicine consultations?

All costs will be decided by the Provider.

### ⊖ How would this affect current premiums?

No change to current premiums.

### ⊖ Is there a ceiling as to the no. of consultations?

A telemedicine consultation will be treated similar to an office visit. The only difference is that the consultation is accessed remotely, using video conferencing or telephone. Therefore, the same existing policy guidelines that govern the contract with the insured will apply.

This means that the deductible, percentage reimbursement and cap will remain the same. For example, an insured with a ceiling of \$1,000 coverage after deductibles can utilise that \$1,000. for:

1. Office visits only
2. Telemedicine consultations only or
3. Combination of office visit and telemedicine consultations

The option utilized is still capped by a total reimbursement of \$1,000.

### ⊖ Can I access coverage for telemedicine services if the provider is not my usual doctor?

This will have to be discussed with the attending physician and agreement made between both parties for the consultation to take place.

### ⊖ Will I be able to use my CariCare Card for these services?

The CariCare card requires a swipe at a physical machine at the provider. As this is not an office visit, you will be unable to use the CariCare card.

Payments must be made in full to the provider before services are received. The provider will determine the payment option (e.g. credit card or bank transfer).

### ⊖ What do I do to get reimbursed?

The Physician fills in the electronic claims form indicating 'Telemedicine' under the heading 'Place of Service - Off./Home/Hosp.'

The provider emails the claim form with validation statement and e-receipt to the insured, who completes the 'member' section and submits all the supporting documents electronically to Sagacor.

After payment has been processed, the money will be wired directly to the insured's bank account and an e-mail notification sent to the insured stating this. "Please note: You must sign up for Direct Credit, in order for

us to make payment directly to your bank account. Cheques will not be issued."

### ⊖ How do I sign up for payment to go to my bank account (Direct Credit)?

Complete and submit our Direct Credit Authorisation Form for Individual Health Insurance Claim Settlement. This is available online at <https://my.sagicor.com/groupweb/viewpdf.asp?filename=182> Direct Credit is a free service and will ensure faster payment of your claim reimbursements directly to your bank account.

You will be notified via e-mail, when the money has been sent to your bank account.

### ⊖ I am a provider not on your pool of telemedicine providers. I am interested in offering this service. How can I become a part?

Thank you for your interest.

1. Providers who have a pre-existing relationship with Sagikor (have already been onboarded) will need to be onboarded specifically for Telemedicine services.
2. New Providers without a previous relationship with Sagikor will need to be onboarded as a Provider and also specifically for Telemedicine services.

### ⊖ Can I open up my telemedicine consultation to new patients?

Whilst our Guidelines to Providers offer advice on this, this is solely up to the providers and should be decided based on regulations and best practice for the industry.

### ⊖ Can insureds go to any doctor who is offering this type of service and get their fees reimbursed?

Yes, a few providers were selected for the initial launch but interested Providers with the capability of offering telemedicine services, will be considered for addition to the pool, after being onboarded.

Claims from providers not currently on the listing will only be reimbursed if the provider applies for and gets approval by Sagikor after being onboarded. This applies to both Providers who are part of our list of approved Providers, as well as doctors not on the existing list.
