This corporate value system is set out in Sagikor's Code of Conduct & Business Ethics. The Code is based on the concept of the moral, ethical and legal obligation owed by Sagikor Directors, Management, Employees and Advisers to various stakeholders. It forms the basis of a number of other detailed policies which are intended to provide specific guidance in assisting all of us in applying acceptable standards of legal and ethical practice to our everyday work.

## **Fraud And Other Wrongdoing Policy**
